Crops grown on the farm are corn and alfalfa for feed along with tobacco that is contracted with Lancaster Leaf Tobacco Company. The farm is being sold to Levi and Priscilla for \$1,200,000. The NGFLP program will be funding \$667,000 of the total with Univest Bank financing \$333,000 and the remainder in borrower equity. The seller will provide an in-kind gift for the non-ag residence.

Project Description: Emanuel J. King Jr. and Lydia L. King will purchase a farm of approximately 95-acres from Emanuel's parents, Emanuel J. and Katie S. King. The farm is located at 1619 Robert Fulton Highway, Quarryville, East Drumore Township, Lancaster County, PA. The farm has a dairy operation marketed to Maryland Virginia Milk Producers Association. Crops grown on the farm are corn and alfalfa for feed along with tobacco that is contracted with Lancaster Leaf Tobacco Company. The total project cost is \$1,117,000. \$167,000 of that total will be for the construction of new agricultural buildings on the property. The farm is being sold to Emanuel and Lydia for \$950,000. The NGFLP program will be funding \$667,000 of the total with the seller financing the remainder. The seller will provide an in-kind gift for the non-ag residence.
